OFFICIAL RULES: The WE Teachers Award

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE CHANCES OF WINNING.

The Contest begins at 12:00 a.m. ET on July 1, 2021 ("Contest Open") and entries must be received online, via WETEACHERS.ORG, no later than 5:00 p.m. ET on January 30, 2022 ("Contest Close"). The Contest is sponsored by Walgreens, located at 200 Wilmot Road, Deerfield, Illinois, 60015 ("Sponsor") and administered and managed by WE Charity, located at 6500 Main Street, Williamsville, New York, 14221. Participation constitutes the Entrant's full and unconditional agreement to and acceptance of these rule ("Official Rules").

- 1. **ELIGIBILITY**. Employees of WE Charity, ME to WE Social Enterprises Inc., Sponsor, or their respective affiliate companies, as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Contest is subject to all, federal, state, and local laws and regulations. Void where prohibited.
- 2. **AGREEMENT TO OFFICIAL RULES.** By participating, the Entrant agrees to be fully and unconditionally bound by these Official Rules, and the Entrant represents and warrants that the Entrant meets the eligibility requirements set forth herein. In addition, the Entrant agrees to accept the decisions of WE Charity and Sponsor as final and binding as it relates to the Contest. The Entrant agrees to hold WE Charity and Sponsor, and their respective subsidiaries/affiliates/agents/representatives harmless from any and all losses, damages, rights, claims, and actions of any kind in connection with the Contest. The Entrant agrees to be responsible for all taxes and all fees associated with the use of the Prize. To be eligible, an Educator may apply or be nominated. **1.** To apply: Educators must complete the application found at WETEACHERS.ORG and if not yet a "WE Teacher", become one. **2.** To nominate: Nominators must complete the nomination found at WETEACHERS.ORG. Nominations that (i) arrive after Contest Close, (ii) are incomplete, or (iii) otherwise do not adhere to these Official Rules may be disqualified at the sole discretion of WE Charity. If the Entrant uses fraudulent, unlawful or otherwise improper methods to enter the Contest, such an Entrant will be disqualified. Odds of winning are dependent on the number of entries.
- 4. **PRIZES.** Each of the three hundred and twenty-five (325) prizes consists of one (1) Walgreens gift card for \$500.00 USD, (a "**Prize**"). Actual/appraised value may differ at the time of Prize award.
- 5. **WINNER NOTIFICATION.** Decisions of Sponsor and WE Charity will be binding in all matters related to this Contest. Winners will not be selected at random. Prize winners will be evaluated and selected by WE Charity on a rolling basis and notified by email on or before February 28, 2022. WE Charity will use the following criteria to evaluate applications and nominations: Complete, Creative and Compelling, Social Cause, Engagement in School Community and Effective Use of Prize Funds. Sponsor and WE Charity are not responsible for any failure to deliver winner notice. Winners must acknowledge and accept their prize within sixty (60) days of being notified. If a potential winner cannot be contacted via email after three attempts, they forfeit their Prize and another winner will be selected. Winners will be required to provide information including, but not limited to, full name, address, phone number, email, birth date, and school name. Winners must also verify the eligibility standards provided in these Official Rules. Prizes cannot be transferred, assigned, or redeemed for cash and must be used at a Walgreens location for economic value. Winners are responsible for all taxes and fees associated with the use of the Prize.

WE Charity and Sponsor assume no responsibility for any application or nomination attempt failure. Applications and nominations are subject to verification and will be declared invalid if they are inaccurate, mechanically reproduced, mutilated, forged, falsified, altered or tampered with or unlawful in any way. Applications and/or nominations submitted by unauthorized means or by spamming will be disqualified. In the event that it has been determined that an application or nomination has been made in a manner not sanctioned by these Official Rules, the Entrant and his/her application or nomination, as the case may be, will be disqualified. The Entrant agrees to abide by the Official Rules and the decisions of the Contest judges, which are final.
- 8. JURISDICTION. THIS CONTEST IS GOVERNED BY THE LAWS OF CHICAGO, ILLINOIS. As a condition of participating in this Contest, Entrant agrees that any and all disputes which cannot be resolved between Sponsor, WE Charity, and the Entrant; and causes of action arising out of or connected with this Contest, shall be resolved individually, without resort to any form of class action, exclusively before a court located in Chicago having jurisdiction.
